GDSN Major Release 3.1 is upgraded in May 2016

In May 2016 GS1 is updating the global standard for trade item information (new version GDSN Major Release 3.1) and in according to that Validoo upgrades the service for validating trade item information – Validoo Item. Prevas GCM is upgraded to the new standard at the same time.

Prevas GCM is verified as a system supplier by GS1/Validoo according to GDSN Major Release

Prevas GCM has been verified by GS1 as a verified system to register and send trade item information according to specification for GDSN Major Release 3.1.

Prevas GCM is closed 6-12 May for upgrading to GDSN Major Release 3.1

Prevas GCM will be closed the same time as Validoo (May 6 at. 00:01 to 12 May at. 23:59) for the upgrade and it will not be possible to log into the system during that period.

Changes in Prevas GCM after Major Release

When you log in to Prevas GCM the user interface would look a little bit different. Functions work much in the same way as before, but for example the terms appear in a different order in the interface.

But Major Release is primarily a change in how trade item information is technically structured and stored in the database as well as the format of the XML files with trade item information that will be sent between Prevas GCM and receivers via Validoo.

Function for register components which is described in GS1 specifications will not be implemented in Major Release. GS1 has decided to implement this function in a later release.

Function for Export all trade item information to an Excel file which has been available via Prevas

GCM support will be implemented in a later release.

Changes in trade item information after Major Release

Changes in trade item information includes:

- Terms renamed, changed T-id, new data type, new terms etc.
- New code lists will replace the current ones.
Many code lists will be similar to code listings in version 2.8.5 whereas other code lists are changed.

Migration of trade item information

Prevas will migrate all trade item information in Prevas GCM from trade item information version 2.8.5 to version 3.1.

This includes all items for all companies using Prevas GCM. For the trade item information that can not be migrated users may need to change their existing trade item information.

Prevas has produced a document to inform how Prevas will handle migrations issues:

Prevas is now working with the migration and will inform the user if changes are required.
